Complete Security

Zatpermit is hosted on Google Cloud Infrastructure, the same secure global infrastructure that powers YouTube, Gmail, and other Google products used by billions of people around the world, providing a consistent and stable application.

Clients can elect to use an existing single sign-on authentication source, preventing duplication of user credentials, minimising administrative requirements and streamlining the user experience.



Flexible Tariffs

Full customisation of tariff options provides significant control over pricing, locations and date time limitations amongst other options.

Tariffs can be applied to multiple locations allowing for a single configuration to be applied across multiple sites as required and enabled as free or priced with the ability to allow applicants to renew via configuration settings.

Along with standard permit functionality there is also the option to use scratch-card configuration allowing a digital format to replace traditional scratch-card booklets should you wish, allowing flexible management and user experience.



Business Rules

Our business rules functionality allows tariffs to be managed by using logic-based rules allowing tariffs to be selectively shown based on applicant account criteria and prior purchases. Discount rules allow for discounts to be applied using similar business logic. Rules can be applied to one or more tariffs reducing duplication whilst providing a powerful provisioning option.

Applicant Questionnaires

Bespoke application questionnaires formed from reusable questions allow applications to be scored and approved, providing a clear audit trail, minimising manual interventions and delays improving the service and transparency for applicants.

Individual questions can be allocated to any Tariff or Site across your Zatpermit account, reducing repetition and administration. Now your most used questions and processes can be applied

Question Weighting

Questions can be weighted allowing for a more considered Approval or Rejection basis, multi-response questions allow each individual option to be weighted allowing for preferences to be made based on the choices provided by the applicant. This functionality provides consistency of approval and scoring, speeding up the administration and approval process.

Weighting becomes incredibly powerful when used in conjunction with Auto-Approval.

Auto-Approval

Auto-Approval works hand in hand with response weighting, with fully configurable percentage banding to allow for Automatic approval or Rejection of an Application based upon the motorist's response.

Whilst rejected Applications can still be individually reconsidered if required, Auto-Approval allows simplified intelligent management of the approval process at scale, reducing the administrative burden and allowing human resource to be deployed where it is more effective.



Customisable Applicant Portals
